As with many daa reports, the devil is in the details. We had two questions regarding the data we are submitting. 1. We assumed the data set we are to report should be Fall 2011, comparable to data from past years, though we didn't find that specified in the instructions as it has been in past years. 2. In reporting enrollment in programs available 50% or more by distance education, we reported data as fractions, with the numerators the subset of unduplicated students in each major who had taken any course online, by interactive video, or telecourse. Since students have the choice of distance Learning or F2F for most (but not all) of our programs, we reported as denominators the total enrollment by declared major in each program it is possible for students to enroll in distance education.
