

## **CHILD CARE SUBSIDY for Lane Students**

The Associated Students of Lane Community College (ASLCC) provide funding to Lane's Child and Family Center for child care assistance to students. The child care subsidy pays a percentage of child care expenses for student parents who's children attend the Lane Child and Family Center. The goal of the subsidy is to ease the financial pressure of child care expenses while also paying college tuition. Funds are limited per term based on department allocations. Subsidy will be applied for all eligible students until funds are exhausted. ***Receiving other child care funding resources such as Co-Op or other child care specific grants and scholarship funding may exclude you from being able to qualify for this subsidy.***

To apply for the subsidy you must meet the following eligibility:

- Be enrolled as a student at Lane Community College taking a minimum of 6 credit hours.
- Children must be enrolled at the Lane Child and Family Center for at least 15 hours per week.
- Parents must be paying at least 60% of child care expenses "out of pocket".

Applications are available in the Child and Family Education department office, Building # 24.

Completed applications must be returned to the Child and Family Education department office for eligibility to be determined. If students receive child care benefits from another source (DHS, Voc Rehab, etc) these benefits are applied first. Subsidy is then applied to the remaining balance. Subsidy eligibility will be determined each term and applied directly to the parent account each term through the college system.

7. If I enroll my child after week 3 I understand the subsidy will be prorated for the remaining weeks of the term.
