<ul style="list-style-type: none"> Analyze how social institutions perpetuate systems of privilege and discrimination, or 	<p>The purpose of this course is to examine the current state of race relations and discourse on race in America. With the election of America's first African American President, has America changed or not as a result of this historic event? This course will examine the primary issues facing African Americans, Latino/Latinas, Native Americans and other underrepresented minority populations. The course is taught primarily through the "lens" of the African American experience.</p> <p>Students are challenged and encouraged to unravel the multi-faceted and multi-layered issue of race in America. The American media has dubbed this current era in our history as "Post-Racial America" a nation that has moved past its angst and conflict over race. Is the civil rights movement over? Has America entered into an embraced a truly "race neutral" society? Are race and racism no longer major factors in our society?</p>	<p>Post Racial America challenges students to examine the media created term. The course asks the question: Are we truly a post-civil rights era society or is this an attempt to shift or change the racial discussion away from the difficult conversations many Americans are still afraid to have?</p> <p>This course looks at the historical roots of discrimination and oppression as a framework for understanding the continuing racial conflicts experienced today.</p>
