| Budget development process | Committee has not advanced much. Greg Morgan mentioned that he will not have time to meet next week because he is going to a conference until Wednesday, which is when the Board of Education Budget committee will meet, and by then they would have gotten the proposed budget. Discussion: |
| By Budget Committee | Member proposed the following 3 options to continue with the budget work: a) meet without Greg; b) Use this meeting to continue working on the budget issues; c) Present a statement to the board saying that once again the college developed a budget that has no input of the governance system. Responses: I don't see the point of meeting today without Sonya C. and Mary S; this council use to work on principles to be used for the budget, I haven't seen it done this year; Yes we did it but without numbers; I like the third option proposed to present our case to the board saying this is why we didn't reach consensus, I don't know what the board will do with that, but at least is the true; If we look the decision metrics of the CC or the charter, is the fault of the college, because it has failed to provide the budget allocations. So what is CC going to do if the college is not compliant with the governance system? I have seen the governance working on strategic directions, planning and facilities, but I don't see it working with the budget; I agree with both previous statements and we should present it to the board because there is no more time to work on it. Proposals: - That a representative of the cc makes a formal presentation to the board, stating that the college has not provided any budget allocations, therefore the budget committee of CC has not been able to give any input. |
