Achievement	Craig Taylor:
Compacts Status	Last May, Lane made projections about what the data would show based on the completion measures from last year. Now we can look at what is actually happening.
	• Expected 1% decline 2011-12 and 3% decline in 2012-13
	• Experienced: GED awards (exceeded goal), Certificates (exceeded goal), AAS (exceeded goals), and Transfers (missed our goal by a bit). Some of the degree awards were the result of a loosening up of the timeframe that we were looking at. This is a one-time bump only.
	Salt/Spilde:
	 Salt is on a sub-committee that is trying to make it clear that improvement of education just by focusing on the outcomes will not be effective. Telling colleges to graduate more students is not constructive and that is what the OEIB is currently doing. Regional compacts may, however, work because it is collaborative instead of competitive. However, as of now, achievement compacts are moving forward. Spilde expects that the achievement compact will remain the same for 2012-13 so we can start the work with setting goals for this year. We do not want to set lofty goals but there are initiatives that should be affecting the success and that should be recognized in our goals. Regional compacts may have some momentum and that is even being looked at in Lane County to include early learning-20. It looks like there is money to do 3 pilots for regional compacts and Spilde would be interested in engaging in this work.
