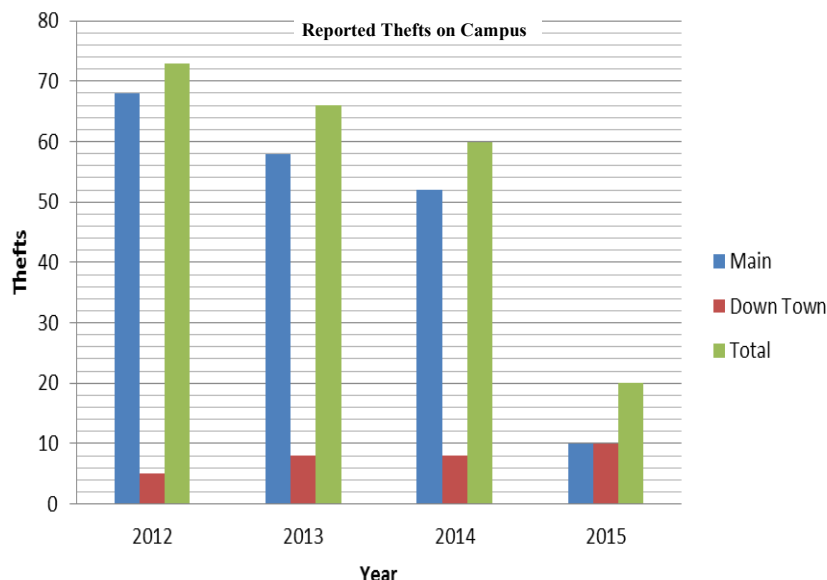
THEFTS ON CAMPUS

In the past three years, and three months of 2015, there has been 219 thefts that have been reported to Public Safety. Unfortunately, Public Safety can not be everywhere, all the time, so it is up to students and staff to stay vigilant, and report suspicious behavior to protect themselves, and class mates, from being a victim of theft.

Since 2012 there has been a steady decrease in over all thefts occurring on LCC property, but in the same aspect thefts occurring down town have rose steadily. Equally alarming is the fact that, in the past three months of 2015, reported thefts occurring down town have already exceeded the reported amount in all of 2014.

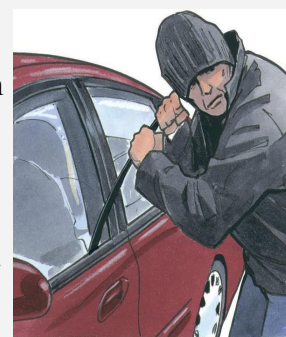

People can protect themselves from being a victim of theft if they live at Titan Court by making sure that they secure all belongings, and stow them away. Stay attentive when using shared space, such as the laundry room, and the bike lock up. Students leave their items unsecured for an extended amount of time, which gives thieves ample opportunity.

DISPATCHER YOU SHOULD KNOW!

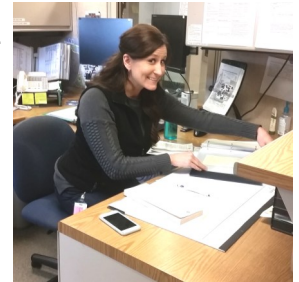


Dispatcher Shawna Reed was born and raised in Eugene, Oregon. Shawna is married and has four lovely children.

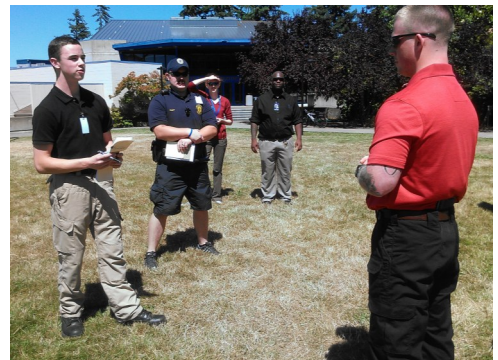

stream, and/or the meninges. Meninges consist of the three membranes that are between the skull and brain, and between the spinal chord and vertebra.

Symptoms of Meningitis can be flu-like such as; fever, headaches, vomiting and stiffness, particularly in the neck. The incubation period can be from two to ten days, but usually symptoms are noticed within three to five days

Meningitis is spread by direct contact with the water droplets from the nose or mouth of an infected person. The spread of the infection is usually from kissing, or sharing drinks, but can be spread in numerous other ways.

The best way to protect your self from meningitis is by getting vaccinated. There is a series of three vaccinations that an individual can acquire to help prevent the infection. The infection is treated by using antibiotics.

Lasting effects of Meningitis can be severe, but most persons will recover fully with medical intervention. Around 13% will, unfortunately, die. Brain damage, hearing loss, chronic nervous system problems can also be lasting effects.

If contact may have been made with someone infected with Meningitis, and symptoms occur, students and staff may contact the Health Clinic at (541) 463-5665 to be screened, over the phone, by a health professional. If symptoms are severe medical attention should be sought immediately from a health provider, or an emergency clinic.

Meningitis is a severe bacterial infection. Meningitis is caused by a germ that affects the blood
