SPRING IS IN THE AIR..., AND SO IS CRIME!

In Oregon, spring means more opportunities to get out of the house and enjoy warmer weather. But it also means more crime, including on campus. This time of year, crime tends to rise sharply, especially theft-related offenses.

Burglary and theft increase more than other crimes during spring, as people leave windows down on their vehicles to keep them cool when they return from a hard day of class. Also, staff members often leave windows and doors unlocked in office spaces to better enjoy the long overdue fresh air and sunshine. Unfortunately, these practices and an ever-changing student body, create many opportunities for thieves to profit and students, staff and visitors to become victims.

Also, Lane's close proximity to I-5 and relative ease of access makes it a convenient target for thieves traveling up and down the freeway corridor.

Thieves typically look for easy targets, where they can easily gain access to unsecured vehicles and buildings to take your valuables. Taking a few seconds to ensure doors and windows are closed and locked can cause a would-be thief to move on without taking your property. Better yet, leave personal valuables at home where they will be safe.

Corporal Jake Ryker

Corporal Ryker has been with LCC's Public Safety Department for over 13 years. He began his career at LCC as a part time, on call officer and was later hired as a full time employee.

Prior to and during his employ-

ment with LCC, Corporal Ryker worked as a loss prevention officer Ryker is enlisted in the Army Refor Sears and Gateway Mall Securitv.

Although Corporal Ryker was born in the Eugene/Springfield area, his family moved around while he was growing up. He regraduated from Thurston High School in 1999.

In 1999, Corporal Ryker enlisted in the Marine Corp and served 8 years at the Eugene Reserve Center. He was involved in two combat tours in Iraq; the first as a Bridge Engineer and the second as an Infrantryman/Machinegunner/ Armorer specializing in Foreign Weapons. During the same tour, he transitioned into the Police Training Team, assisting in the training of approx. 3,000 Iraqi police officers. Today, Officer serve.

Corporal Ryker is certified to teach Defense Tactics, Extendable Baton training and Aerosol Restraint Subject (ASR Pepper spray) courses to law enforcement. He turned to Springfield at age 13. He has also completed the Emergency Medical Technician Basic Course at LCC, and has been nationally certified as an EMT.

> Most recently he was reclassified as a PS-2, in recognition of his extra, permanent responsibilities in Public Safety.

In his spare time, Ryker enjoys riding his Yamaha FZ1 sport bike, restoring his 1969 Ford Mustang and spending time with his wife, daughter, and son.

CANC SYMPOSIUM ON CAMPUS

"Vulnerable, not tough" was the message at the Lane County Gang Symposium held on Saturday at LCC's Main Campus. The event was attended by nearly 300 people, including community members, gang members and former gang members, potential gang members, relatives, counselors, teachers, clergy, law enforcement and local media. Corporal Lisa Rupp represented the Public Safety Department. Attendants met for six hours to "listen, learn and talk" about youth gangs in the area.

The effort was launched two years ago by Eugene Police Chief Pete Kerns in an effort to prevent young men and women from seeking gang membership as a way of life.

The discussion centered around a panel of ex-gang members, four men and a woman, who spent large parts of their 20s and 30s in gangs. Participants were broken up into seven groups, based on each individual's self-identified status in the community. These groups included: Community, Mixed, Municipality, Schools, Law Enforcement, Youth Serving Organizations and Faith-Based Organizations.

During the symposium, scripted questions were asked by "Table Captains", who facilitated conversations at tables of several participants. Data was obtained and transcribed from responses written by these people, with any personal identifying information removed, to be later used for data analysis.

"The state prison here is full of gang members from Eugene and the Springfield area," said Joey Whittaker, who said that five years ago he was one of them. "If you sit around and are complacent on this issue, you're going to have metal detectors in your schools."

The assembly was warned to take gang "wannabes" seriously, as, in "proving" themselves, they can be just as violent as actual gang members.

Many participants voiced frustration that there was "a lot of talk and no action" surrounding the issues of gangs in this community. They felt there should be more follow up concerning the issue. Community members seemed to genuinely want to help, but did not know what actions they should take.
