


Credit FTE are derived from the following reimbursement categories: lower division collegiate, professional technical preparatory, and post-secondary remedial.







Total reimbursable FTE decreased 0.1% during 2011-12. Reimbursable FTE are derived from most courses taught and students enrolled at Lane. Courses yielding non-reimbursable FTE (i.e., these FTE are not considered in the state funding formula) are described by state instructional guidelines and can be generally categorized as certain types of hobby or recreation courses. Out-of-state students also yield non-reimbursable FTE.

Reimbursable FTE are used in the state funding formula. See "Community Education FTE" for more explanation of reimbursable courses.







LDC FTE for Lane increased 1.9% in 2011-12.






Career and Technical FTE



Career and Technical courses include the reimbursement categories of Preparatory, Supplementary, and Apprenticeship. FTE in this broad group decreased 6.2% in 2011-12.

Some courses included in this FTE category are offered through College Now and Lane's RTEC programs; both enable high school students to begin to train for a technical career while still in high school and to earn college credits while doing so.
