1. Facilities Council

2. Accident and Incident Reports

- Outside lights around campus need to be re-evaluated. Specifically outside building 19.
 Suggestions were to research either a later turn off time or motion sensors.
- We need to research the A/R drop box situation to see if there is a way to reduce the risk of finger smashing.

3. Indoor Air Quality Visit- Rich Prill

- Rich Prill and Jennifer Hayward gave initial report on campus assessment.
- They looked at Buildings; 5, 8, Center, DTC, 16 and the Cottage Grove Campus. Others may have been assessed as well.
- Mr. Prill has been developing IAQ programs in the region for about 10 years. He has assisted in over 500 schools, mostly K-12.
- There are 5 benchmarks that are evaluated
 - 1. Dry
 - 2. Clean
 - 3. Comfortable
 - 4. Controlled Pollutants- Keep out what you can, control the rest.
 - 5. Ventilation Air flows, and CO2 meter.

- They have not found any serious problems in any of the buildings.
- The standard of housekeeping is not as high as he would expect.
- We need to clean for health, not appearance.
- He will be giving a report to college tomorrow reporting his findings.

4. Re-listed Action Items from previous meeting.

- Wilkes will resend the email with the list of buildings suggested for evaluation in IAQ
- Hayward will contact unions regarding the IAQ walk around
- Dumbleton will contact Bob Baldwin with information regarding the Safety Committee not being responsible for department specific policy.
- Barth will check R25 for scheduling of room with new time.
- Atkins will make sure Jewelry grinder is tagged out.
- Ing-Wiese will train the IT manager's (Lutz and Pruch) on proper completion of accident/incident form.
