4. Transportation Projects

a. Confirm next steps (developed at last meeting)

The Committee reviewed the "Next Steps on Transportation Demand Management" document. Brian commented that the Rainforest Action Network's "Change the Course: People Powered Strategies for a Stable Climate" visioning session agenda template, that is mentioned under item 2.c., is great and the Committee should definitely consider using it. Jennifer will send the agenda template to the Committee. Additions to the list were:

- Document Lane's current Transportation Demand Management strategies and status of transportation infrastructure (i.e. how many car and bike parking spots).
- Conduct a SWOT analysis (SWOT = Strengths, Weaknesses, Opportunities, and Threats) on current transportation infrastructure and strategies.
- Russ is a builder and Pamela is a nurturer.

b. Review and fill out Transportation Management Plan Change Maker Sign-up Sheet

Jennifer distributed the Transportation Management Plan Change Maker Sign-up Sheet that Claudia created for this meeting. Committee members broke out into two groups to plan out tasks. The two groups were:

- Investigators: Jennifer, Kathy, and Claudia
- Builders/Nurturers: Russ, Mike, Patty, Anna, Brian, and Pamela

The Committee also agreed that we would have a third group of "Communicators, Networkers, and Resisters" with Wendy, Claudia, and Jim as members. Wendy was the only representative of this group present at this meeting. Wendy will contact Claudia and Jim to begin planning tasks for their group.

Tasks planned by each group were:

Investigators:

- Jennifer will work with Mike and Russ to help pull together the existing conditions data
- Kathy to send Margaret and Jennifer links to TDM plans that she had already found.
- Kathy, Jennifer, and Margaret (Investigators) to divide up reviewing the plans over e-mail by 12/12/14.
- Investigators to meet to review and sort out findings during the week of 1/5/14 (Jennifer to send appointment).
- Investigators to focus research on:
 - What other colleges and universities in Oregon are doing;
 - What other commuter-type community colleges are doing;
 - What "exemplar" schools are doing.

Builders/Nurturers:

- Work on shelter for 82 bus stop to help protect people who ride the 82 from the rain.
- Work on having a landing spot for people who use alternative forms of transportation somewhere to dry off and get ready for your day.
- Ensure that part-time folks are including in strategies.
- Work on having an air station for bikes and a spot for minor bike repairs.
- Doing more work on carpool system.

Mike noted that that some of this work is already under way through the BikeLane project. He suggested presenting these projects to the Committee at a future meeting and all agreed.

Next Steps on Transportation Demand Management

- 1. a. Inventory what we are doing now.
 - b. Investigate Transportation Demand Management plans
- 2. Involve the campus and the community:
 - a. Get students involved
 - i. OSPIRG
 - ii. See if there could be a transportation-related class project. Potential classes include:
 - 1. SUST 101
 - 2. ENVS (any? Ask Claudia for suggestions.)
 - 3. Business/Investment/Management classes
 - 4. Political Science classes (research governmental partnerships).
 - b. Get input from campus community
 - i. Maybe through a survey, a global conversation, or SWOT Analysis.
 - c. Hold a visioning session similar to the Rainforest Action Network's "Change the Course: People Powered Strategies for a Stable Climate" vision session (http://www.ran.org/changethecourse), except for Lane's transportation future.
 - d. Determine whether there is a connection between the Transportation Demand Management Plan and the Strategic Direction Development work that is going on. Could implementation of a Transportation Demand Management Plan be a Strategic Direction?
 - e. Organize a transportation summit to foster collaboration between Cities, County, LTD, and LCC on improving bike and pedestrian routes and transit to Main Campus
- 3. Create a draft plan that includes pathways for how to get to our goals
 - Using 2006 Long-Range Transportation Committee Report, Climate Action Plan, Transportation Demand Management Plan research, and input from Campus Community.
- 4. Review draft with Facilities Council
- 5. Simultaneously be doing a promotional campaign, events, and implementing any items from the Long-Range Transportation Report and the Climate Action Plan Land Use and Transportation Section that are do-able now.
